



Dr. Jacqueline N. Font-Guzmán, Professor, Werner Institute at Creighton University School of Law - Professor Font-Guzmán is a certified mediator and arbitrator by the Puerto Rico Supreme Court. She is a Fulbright Scholar who has actively participated in the field of conflict studies through national and international conferences and workshops, and has conducted a wide variety of trainings and seminars in the field, throughout the United States, the Caribbean, Europe, and Latin America. Some of the organizations she has provided mediation, facilitation and/or training services to include the: World Health Organization, U.S. Postal Service, Judicial Academy of the Puerto Rico Supreme Court, Spanish Supreme Court Judicial Council for Continuous Education for Judges, Venezuela Supreme Court, Johnson & Johnson, and the Nebraska Bar Association. She has also been a visiting professor at the University of Puerto Rico Law School in San Juan, Puerto Rico and at Carlos III University School of Law in Madrid, Spain. Ernie Goss, Professor of Economics, Heider College of Business - Professor Goss is currently the MacAllister Chair and Professor of Economics at Creighton University in Omaha, Nebraska, and Director of the Goss Institute in Denver, Colorado. He is also a Research Faculty member at California State University-Fresno. Dr. Goss was a visiting scholar with the Congressional Budget Office and the National Aeronautics & Space Administration. He is editor of Economic Trends, an economics newsletter published monthly that is distributed to more than 9,500 subscribers. To gauge regional economic condition, Goss conducts a monthly survey of bank CEOs in rural areas of 10 states and a monthly survey of supply managers in 12 states. Results from the two surveys are carried in over 100 newspapers, 50-100 radio stations and scores of other media outlets each month. Recent citations appeared in the Wall Street Journal, Business Week, Forbes, and The Economist, as well as regional newspapers such as the Denver Post, Kansas City Star, and the Minneapolis Pioneer Press. Dr. Maorong Jiang, Associate Professor of Political Science and International Relations, and Director of the Asian World Center at Creighton University - Born in China, Dr. Jiang began his teaching career at the age of 18, and taught international relations as a regular faculty member in the Department of International Relations at the Military College of International Relations in China. He would begin his graduate studies at the Beijing Foreign Affairs College and complete them in the U.S. at the University of Hawaii at Manoa with a MA in Asian Religions and a Ph.D. in Political Science with a focus in Future Studies. Dr. Jiang has studied at the China-Europe Institute at The Catholic University of Leuven in Belgium, Munich University in Germany, USIA, and the East West Center in Honolulu. Since 2003, Dr. Jiang has been with Creighton

University, building the Asian World Center from the ground up, and also constructing a name for himself as a well-respected authority on the affairs of Asia, the United States, and the world. Edward A. Morse, Professor of Law, Creighton University School of Law - Professor Morse holds the McGrath, North, Mullin & Kratz endowed chair in Business Law at Creighton University School of Law. He teaches courses in taxation, business associations, and antitrust, and his scholarship often focuses on the intersection of law, technology, and regulatory practices. He is also an affiliated senior scholar in the Institute for Economic Inquiry at the Heider College of Business. In addition to academic publications, his narratives have appeared in the Economist, NPR Marketplace, CQ Researcher, and other media outlets. He also speaks and consults regularly on topics related to his research and teaching interests, reflecting his commitment to integrating and connecting academic knowledge with broader communities outside the academy, including the practicing bar.
